SECTION 7: Handling and storage

7.1. Precautions for safe handling

Ensure the complete gas system was (or is regularily) checked for leaks before use.

Do not smoke while handling product.

Use only properly specified equipment which is suitable for this product, its supply pressure and

temperature. Contact your gas supplier if in doubt. Avoid suck back of water, acid and alkalis.
