SECTION 7: Handling and storage

7.1. Precautions for safe handling

Safe use of the product

The product must be handled in accordance with good industrial hygiene and safety procedures.

Only experienced and properly instructed persons should handle gases under pressure.

Consider pressure relief device(s) in gas installations.

Ensure the complete gas system was (or is regularily) checked for leaks before use.

Do not smoke while handling product.

Use only properly specified equipment which is suitable for this product, its supply pressure and temperature.

Contact your gas supplier if in doubt.

Avoid suck back of water, acid and alkalis.

Do not breathe gas.

Avoid release of product into atmosphere.

Containers, which contain or have contained flammable or explosive substances, must not be inerted with liquid carbon dioxide. Potential production of solid CO2 particles must be ruled out. In order to rule out

Safe handling of the gas receptacle

When moving receptacles, even for short distances, use a cart (trolley, hand truck, etc.) designed to transport receptacles.
