SECTION 7: Handling and storage

7.1. Precautions for safe handling

Safe handling of the gas receptacle

Safe use of the product

: The product must be handled in accordance with good industrial hygiene and safety procedures.

Only experienced and properly instructed persons should handle gases under pressure.

Consider pressure relief device(s) in gas installations

Ensure the complete gas system was (or is regularily) checked for leaks before use.

Do not smoke while handling product.

Use only properly specified equipment which is suitable for this product, its supply pressure and temperature.

Contact your gas supplier if in doubt. Avoid suck back of water, acid and alkalis.

Assess the risk of potentially explosive atmospheres and the need for explosion-proof equipment.

Purge air from system before introducing gas.

Take precautionary measures against static discharge.

Keep away from ignition sources (including static discharges).

Consider the use of only non-sparking tools.

Do not breathe gas.

Avoid release of product into atmosphere. Ensure equipment is adequately earthed.

Do not allow backfeed into the container.

Protect receptacles from physical damage; do not drag, roll, slide or drop.

When moving receptacles, even for short distances, use a cart (trolley, hand truck, etc.) designed to transport receptacles.
